

## Terms used in the Public Register

| Term  | Explanation  |
|---|--|
| <i>Current Status</i>                                       | <p>The kinesiologist's current registration status with the College. This can be one of the following:</p> <ul style="list-style-type: none"> <li>• <b>Active</b>- Eligible to practise in Ontario</li> <li>• <b>Inactive</b>- Not eligible to practise in Ontario for a specified reason (e.g. parental or academic leave, moved to another jurisdiction)</li> <li>• <b>Suspended</b>- Not eligible to practise because their certificate of registration (i.e. licence) is suspended due to an investigation or disciplinary matter. The reason will be noted in the kinesiologist's profile under <i>Concerns</i>.</li> <li>• <b>Suspended (Administrative)</b>- Not eligible to practise because their certificate of registration is suspended for administrative reasons (e.g. not paying annual renewal fees, not providing proof of insurance)</li> <li>• <b>Resigned</b>- Not eligible to practise because the kinesiologist voluntarily resigned their certificate of registration</li> <li>• <b>Revoked</b>- Not eligible to practise because the College revoked the kinesiologist's certificate of registration. The reason for the revocation will be noted in the kinesiologist's profile.</li> </ul> |
| <i>Join Date</i>  | The day the kinesiologist became registered with the College   |
| <i>Valid Until</i>  | The day the kinesiologist's certificate or registration expires and they must renew <b>OR</b> the date the kinesiologist resigned (if applicable)  |
| <i>Referrals/Findings</i><br>(found under <i>Concerns</i> ) | <p>Concerns the College has investigated or will investigate against the kinesiologist, and the outcomes of this process. Information found here can include:</p> <ul style="list-style-type: none"> <li>• Cautions (written or in-person) delivered to the kinesiologist by the Inquiries, Complaints and Reports Committee (ICRC)</li> <li>• Continuing education or remediation programs the ICRC orders the kinesiologist to complete</li> <li>• Information about current and past hearings before the Discipline Committee related to professional misconduct or incompetence</li> <li>• Information related to any known: <ul style="list-style-type: none"> <li>○ Current criminal charges and bail conditions</li> <li>○ Criminal convictions</li> <li>○ Findings of malpractice or professional negligence</li> <li>○ Findings of professional misconduct or incompetence in another jurisdiction</li> </ul> </li> </ul>   |
| <i>Terms/Conditions</i><br>(found under <i>Concerns</i> )   | Any terms, conditions or limitations the College imposes on the kinesiologist's certificate of registration  |
| <i>Employment</i>   | The kinesiologist's known current employer(s). For kinesiologists who resigned, are suspended or revoked, this list only includes their last known employer(s).  |
